ECALS Terms of Use

[Rule Number : ECALSUS07]

Mar. 31, 2014

Issued by ECALS committee EC Center Japan Electronics and Information Technology Industries Association

(Article 1 : Objects)

JEITA EC Center (Japan Electronics and Information Technology Association EC Center) enacts the rules and standards about product technical information for Electric Components, Semiconductors and Liquid crystal display devices (call product information in follows).

The roles of the JEITA EC center are,

- ECALGA-ECALS standard maintenance and expansion about Product information editing and authoring and circulation.
- Enacting regulations about Products information that based on ECALS standard for publication and circulation.
- Enacting rules about ECALS users

ECALS users must follow rules of this document to manage or use information provided by ECALS.

(Article 2 : Agreement and application)

This document applies to ECALS users.

Applicants to use ECALS shall accept the ECALS TERMS OF USE (ECALSUS07) to enroll.

(Article 3 : Division of user)

1) There are 3 kinds of ECALS user

- (1) Product information provider (called "C" user)
- (2) Product information user (called "D" user)
- (3) Management service partner user (called "P" user)

Currently, users out of Japan are allowed to enroll as "D" user only.

Therefore, this document only shows terms about "D" user.

2) "D" users right and corresponding duty

- (1) "D" user can browse or download information that "C" users provided.
- (2) "D" user shall follow "Guide line about using ECALS content for "D" user(ECALSUS14) ".

(Article 4 : Application for use)

- 1) Applicant should become registered user by enrolling from user registration page of the JEITA EC Center's Website.
- 2) In principle, only business organizations, groups or institutes can enroll to be "D" user._For any other individuals who wish to be "D" user, the JEITA EC Center will make the decision on a case-by-case basis.

- 3) "D" user needs to have a chief administrator in charge of administrating information obtained from ECALS.
- 4) Enrollment shall be made by the chief administrator.
- 5) Applicant shall input accurate and up to dated information to enroll

(Article 5 : Registration of affiliate user)

1) Registered "D" user (parent user) can enroll its arbitrary unit as affiliate user.

- 2) Management representative in charge of administrating affiliate user and information obtained from ECALS is needed..
- 3) Affiliate user registration shall be enrolled by the management representative in charge of administrating affiliate.
- 4) Affiliate user registration requires acceptance of the ECALS TERMS OF USE and to input user information, parent user ID and the parent's password.

(Article 6 : Consent and revoke)

1) Receipt date is the date that the JEITA EC Center confirmed contents of the enrollment.

If the enrollment is declined, the JEITA EC Center does not owe the obligation to notify to the applicant.

2) If the enrollment is accepted, the JEITA EC Center will send an e-mail about user ID and temporary password.

Enrollment for affiliate user will be accepted when the JEITA EC Center confirmed contents of the enrollment. Then the JEITA EC Center will e-mail user ID and temporary password.

- 3) For any fallacious input to enrollment or the JEITA EC Center judged purpose of use is inappropriate, the JEITA EC Center reserves right to decline the enrollment.
- 4) The JEITA EC Center may request to stop from using if the user violates the ECALS TERMS OF USE.
- 5) In case of 4) or 5), affiliate user may also be prohibited to use ECALS.

(Article 7 : Responsibility to manage ID and password)

1) User ID and password shall be managed by the chief administrator.

- 2) To use ECALS, members of "D" user including affiliate user are required to input user ID and password given to the chief administrator by the JEITA EC Center.
- 3) The chief administrator to bear full responsibility to manage user ID and password..
- 4) "D" user has responsibility for damages caused by improper management of the user ID and password.
- 5) The chief administrator shall report to the JEITA EC Center immediately if user ID or password is stolen or compromised.

(Aticle 8 : Notfication from the JEITA EC Center)

- 1) Nofication from the JEITA EC Center will be sent by e-mail, upload to JEITA EC center's website or other method that the JEITA EC Center thinks appropriate.
- 2) The JEITA EC Center assumes notification's completed to users when the notice is uploaded to the website as general notification.
- 3) In case of e-mail notification, the JEITA EC Center assumes the notification's completed to users when e-mail is sent out to email addresses that users inputted at enrollment.
- 4) The JEITA EC Center will consider users accepted the notification at the date unless objection is provided.

(Article 9 : Information and services that the ECALS site provides)

The ECALS site provides information and services as below:

- (1) Provide the EC Center standards for browsing and downloading.
- (2) Provide revision information of the JEITA EC Center standards.
- (3) Ask for suggestions about the JEITA EC Center standards.
- (4) Provide company information of "C" users and "D" users for browsing and downloading.
- (5) Other notification from the JEITA EC Center

(Article 10 : Prohibited acts)

- The "D"user is prohibited to do following acts. Infringement of copyright of the JEITA EC Center, ECALS standards or other users.
- 2) Infringement of assets or privacy of JEITA, the ECALS standards or the JEITA

EC Center.

- 3) Act of slander and slandering other users or this societies, ECALS standards, and EC center
- 4) Inputting or posting fallacious information.
- 5) Other activities that the JEITA EC Center judges inappropriate to promote ECALS.

(Article 11 : Usage and disclosure of user information)

- 1)To promote the ECALS standard information, JEITA and the JEITA EC Center reserve right to use information that users inputted.
- 2)_JEITA and the JEITA EC Center shall not disclose user information to any other third parties except other users without permission.

(Article 12 : Prohibition to divert information)

Users can download or browse information from the JEITA EC Center website to utilize for their business. However, diversion of the information to any other third parties, whether with or without consideration, is prohibited unless otherwise contracted.

(Article 13 : Compensation for damage)

If user violated this rule or the law, and caused damage to JEITA, the JEITA EC Center or any other third parties including other users, the user shall be liable for the damage.

(Article 14 : Suspension procedure)

1) To suspend to use, the user needs to send a notification to the secretariat which appears on the JEITA EC center website.

There is no designated form to fill in but please provide information listed below:

1.Cooperate name, 2. Standard cooperate code, 3. User ID, 4. Name of group,

<u>5. Name and title of the person in charge</u>, <u>6. Postal code</u>, <u>address</u>, <u>telephone</u> number, FAX number and e-mail address, <u>7. Reason suspending to use</u>.

2) The user may be suspended to use from the date that the JEITA EC Center secretariat receives the notification.

(Article 15 : Disclaimer)

This society and the JEITA EC Center will not be liable to users or any other third parties for any damages arising out of delay, change, interruption, stoppage,

suspension or discontinuation of the ECALS standard information unless otherwise contracted..

(Article 16 : Others)

User and JEITA or the JEITA EC Center shall endeavor in good faith to settle any disputes arising from use of the ECALS standard information by negotiations. It is Tokyo District Court as for the competent court when the judicial decision is needed.
